

## Alan Schnitzer's CEO Violations

Alan Schnitzer, CEO, when a CEO of a publicly traded company learns of an expert witness's poor comments regarding fraud, the main legal obligations include ensuring compliance with securities laws, particularly those related to disclosure and preventing fraud.
